## **Resolution No. 06-2013-135**

**( Approving Land Board Meeting Minutes for March, April, May, and June 2013 )**

**WHEREAS,** the Land Board has presented minutes for Council review for meetings occurring on the following dates:

March 28, 2013

April 25, 2013

May 29, 2013

June 11, 2013

; and

**WHEREAS,** the Land Board requests that the Council approve their formal adoption to maintain the historical record for any future purpose or review by the public; and

**WHEREAS,** the Tribal Council has reviewed the minutes presented and appreciates the commitment of members of the Land Board, and finds it in the best interest of the Tribe to approve the minutes presented.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby formally receives and approves of the Land Board meeting minutes as presented today memorializing Land Board activity for the months of June, July, and August of this year.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.


**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances or Federal Laws, this Resolution shall be declared null and void and have no legal effect.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Acting Chairman, is authorized to execute any documents necessary to effectuate the intent of this Resolution. In the event the Chairman fails to delegate signatory authority to an Acting Chairman, the Vice-Chairman may sign.

The foregoing resolution was on JUNE 12, 2013 duly adopted by a vote of SIX for, ZERO against and ZERO abstention pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (h), (i), (m), (r), (s), (t) and (u) of the Tribal Constitution, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
