Resolution No. 03-2014-32

(Appointing Chadwick Amos as the Chief Game Ranger)

WHEREAS, the Tribal Council (“Council”) of the White Mountain Apache Tribe (“Tribe”) is aware that the Chief Game Ranger position is currently vacant and has been occupied in the interim by Tribal Member Chadwick Amos; and

WHEREAS, Mr. Amos has admirably served the Tribe as Acting Chief Ranger and up for Council consideration is whether the Tribe should promote Mr. Amos to Chief Game Ranger or advertise the position and interview all qualified candidates; and

WHEREAS, after much discussion and deliberation, the Tribal Council finds that it is in the Tribe's best interest to appoint Chadwick Amos as Chief Ranger in recognition of his hard work and excellent manner in which he has conducted his duties on behalf of the Tribe.


BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby appoints Chadwick Amos as the Tribe's Chief Game Ranger and that the “acting” designation be removed from his title, effective immediately. From this day forward, Chief Ranger Amos shall be afforded all of the rights and privileges enjoyed by full-time permanent employees of the Tribe.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances or Federal Laws, this Resolution shall be declared null and void and have no legal effect.


BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Acting Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution. In the event that the Chairman fails to delegate signatory authority to an Acting Chairman, the Vice-Chairman may sign.

The foregoing resolution was on **MARCH 13, 2014** duly adopted by a vote of **SIX** for and **ZERO** against and **ONE** abstention by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (c), (s), (t) and (u) of the Tribal Constitution, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
