(Approving Non-Tribal Member Hunting Regulations for 2014-2015)

- WHEREAS,** the Tribe's Game & Fish Department did this day come before the Tribal Council to request approval of the Non-Tribal Member Hunting Regulations for 2014-2015, as attached and incorporated by this reference; and
- WHEREAS,** Game & Fish staff advised the Tribal Council that the hunting seasons, bag limits and regulations are based on sound biological principles, surveys and methods; and
- WHEREAS,** the Tribal Council has reviewed the recommended Regulations and concurs that these will provide sustainable management of Tribal wildlife resources; and
- WHEREAS,** the Tribal Council finds that the Non-Tribal Member Hunting Regulations for 2014-2015 are in the best interests of the natural resources within the Fort Apache Indian Reservation and the Tribe.


BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Non-Tribal Member Hunting Regulations for 2014-2015, as attached and incorporated by this reference, are hereby approved.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances or Federal Laws, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.


