



WHITE MOUNTAIN APACHE TRIBE

A Sovereign Tribal Nation

(Approving Apache Youth Programs In-House Promotions)

WHEREAS, there has been an in-house promotion of Assistant Director Rose M. Kasey to become the Executive Director the Apache Youth Programs, Dorris Hinton, from Student Specialist to Assistant Director of Operations and hiring Garilyn Denise Alchesay as the Office Clerk from her current position as a Sub-Contractor to the program; and

WHEREAS, immediate action is needed in order to provide antequate service to members of the Apache Youth Program; and

WHEREAS, the Tribal Council finds it in the best interest of the Tribe to support the efforts of the White Mountain Apache Youth Programs and concurs with the in-house promotions.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes and approves the internal changes in staff as follows: in-house promotion of Assistant Director Rose M. Kasey to become the Executive Director of the Apache Youth Programs, Dorris Hinton, from Student Specialist to Assistant Director of Operations and hiring on Garilyn Denise Alchesay as the Office Clerk from her current position as a sub-contractor to the program.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances or Federal Laws, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on AUGUST 6, 2014 duly adopted by a vote of SIX for and ZERO against with ONE abstaining by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it under the enumerated powers listed in Article IV, Section 1 of the WMAT Constitution, so ratified on September 30, 1993, and federally recognized pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984).
