(Approving All Land Board Meeting Minutes from November 2013 through July 2014)

- WHEREAS, the Tribal Council of the White Mountain Apache Tribe ("Tribe") is entrusted by the Tribe's Constitution to act in all matters that concern the welfare of the Tribe, to manage all economic affairs and enterprises of the Tribe, and to regulate subordinate organizations for economic and other purposes; and
- WHEREAS, the Land Board has on this day presented before the Tribal Council the minutes of meetings conducted on November 05, 13, and 20 of 2013, January 26, 2014, February 26, and 28 of 2014, March 04 and 13 of 2014, April 09, 16, 23, 24 and 30 of 2014, June 23 and 25 of 2014, July 09, 16, 17, 25, and 30 of 2014 in hopes that the governing body will approve their formal adoption to maintain the historical record for any future purpose or review by the public; and
- WHEREAS, the Tribal Council has reviewed the minutes presented and appreciates the commitment of members of the Land Board and finds it in the Tribe's best interest to approve the minutes presented.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby formally received and approves the Land Board meeting minutes as presented today memorializing Land Board activity for the months of November 2013, January, February, March, April, June, and July of 2014.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances or Federal Laws, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on <u>AUGUST 07, 2014</u> duly adopted by a vote of <u>SEVEN</u> for and <u>ZERO</u> against with <u>ONE</u> abstaining by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it under the enumerated powers listed in Article IV, Section 1 of the WMAT Constitution, so ratified on September 30, 1993, and federally recognized pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984).

	from Raymus. The land in question belonged to Celine	
	Goklish. There are many people who complained	
	about the land but everyone knows the land belongs to	
	Celine. Back in the old days there was no paperwork.	
	Nothing was documented like it is today. Everything	
	was based on words. Land was given out verbally. Just	
	recently they started putting everything down on	
	paper. We are from Cedar Creek and being from there	
	land was assigned out verbally. Nothing was put on	
	paper. When we wanted to give out land, Raymus	
	advised us to find out the information on who owns	
	the land and ask permission. This land belonged to	
	Celine and Celine gave it to Cheryl and Emil in front	
	of the land board. It was approved by the land board.	
	They asked a lot of question on it but there was no	
	paperwork on it, so the land board approved it for	

them.

Elvis: What year did this all take place?

Emil: We moved into our home in 1997. It takes 2 or 3 year to build a house. We went to the board meeting and it was given to us. So between 96, 94 or 95. If you guys had given us time I would have looked for the papers. I got the letter on Tuesday. It was left on my car that wasn't working on Monday and I found it Tuesday.

Gertie: The land board moved a few times. There was a fire too and my papers, for my land was lost. But this land was given to these two in the board meeting. Even Joe (Harvey) was there at the meeting. I had advised him to get on the board from North Fork. I had encouraged him to get on the board. There are many young people working now and we need someone like Joe (Harvey) to help the people. All these years no one was complaining until now.

Emil: Since we got the land I started fencing around the land. All this time I was fencing the land nobody said anything to me. Except for Michael Bin and Isaac. They approached him and said that the land he was fencing up wasn't theirs. He said the land belonged to Chief Baha but Celine said that the land didn't belong to Chief Baha.

Elvis: Gertie you said you were on the land board. What year did you get on? And what years did you guys start putting things on paper work?

Gertie: In 86 or 87 I was on the board, and by then there was paperwork on file for land. When I was there we never took land away from people. We helped people out.

<u>Elvis:</u> When you got on the land board did you get a copy of the paperwork?

Emil: Yes we did, but I didn't have a chance to bring in paperwork.

Elvis: Celine this was your land. Can you tell us the history of this land?

Celine: This farm land belonged to Sidney's dad, who was a stockman, who got thrown out for stealing cattle. This land belonged to my husband. It was given to him by this dad. I gave a piece of this land to my daughter Cheryl and her husband to get their house built on, but the farmland is in my name. I want to plant and I want the farmland in my name. The Kasey's have been giving these two problems since they moved in. Saying that belongs to them because of

	Chief Baha. They even got mad at her for the land, I	
	relinquished to my daughter and her husband.	
	Emil: The land was given to us in the board meeting.	
	My thought was it was approved by the board so it	
	should be good. I was in my 20's and the thought of	
	getting it on paper never crossed my mind. I trusted	
	the board in a boarding meeting. Does the land board	
	word mean anything? Can anyone take the land away	
	after the land board gave the land to us? I remember	
	going there with Joe and with Nathaniel to the home	
	site.	
	Phoebe: Do you have any idea what year your	
	homesite application was approved?

Rosie Garcia: What my brother said is true. My brother Rolland had given us the land.

Elvis: After your mom passed away, did you ever do any paperwork with the land office?

Regan: No. We went through it traditional way. You have to do things by traditional law and that is what we followed.

Joe Harvey: What year did your mom passed away? Regan: In 2006

Judy Armstrong: I would like to say something. I am part Hopi and Navajo. In my tribe, you can't just take land away and reassign it without notifying the person. You have to ask for permission. I have been married to Regan for 40 years and since I have been a part of his family and June has never been there. She was mean and always fighting amongst the family. On the Navajo tribe when you apply for land, you don't get it anywhere you want. There is a process. The land you get assign goes by where you came from, your clan and where your family lives. Not like it is here. A person from Seven mile can't get land in Forest Dale. Even if you are married into the family. When your spouse dies, that land doesn't go back to you. You go back to where you came from. That's how we Navajos do it. My advice to you is to do your history and take into consideration how the Navajo tribe does their land assignments, so something like this won't happen again. Land is sacred to us people. It has meaning. Land Board shows Regan the paperwork that the land in Forest Dale is in his brother Rolland Armstrong's name.

Regan: You don't know how June treated my brother. This land belonged to our family. Everyone who has a piece of that land is closely related. You should have told us about the paperwork before anything started because how I see it, Rolland gave the land to Rosie and I verbally. Now it doesn't count because you wanted it on paper. But it was our fault too because we never did it that way.

Arnold Beach: I would like to say something McDaniel marked the land the first time. The second time we met with him. It was myself, Jack, Beverly and a few others. We parked at the baseball field and walked over the area with McDaniel and he showed us the points. We trusted his job and left it at that. Now there was no issue about the land overlapping other people's land or about the community complaining. At that time the McNary community president Consoni Hill had went out into the community and got signatures for Jack and Beverly stating that the community would like to have a McNary Baptist church.

<u>Joe:</u> According to the application you were approved for 2.29 acres.

Jack: I understand but my question is if we are not encroaching on other people's land then I would like the markings that McDaniel originally put in the ground be added to the 2.29 acres surveyed. We are community oriented and have been helping the community. I don't get paid under the church. I work and what I get paid I put into the church. I am asking that the Land Board accept what was marked by McDaniel.

Joe: Jack, what do you think about the burial site that was on the property where you cleared out? Jack: The area has already been cleared out and there were no marked grave sites. All we know is that they were hung in the trees and all those trees have already been cleared. So really there is not much you can do. Joe: I agree with you Jack. There was an area like that where Cradle Board is at now. Today you see houses and a school built there so it is not considered a grave site.

Elvis: Arnold you said you were there when McDaniel showed Jack and Beverly the markings. In my opinion, as a surveyor, there is no way a surveyor can make this big of a mistake. I agree that no two surveys will turn out the same but the difference would be in a couple of inches to a foot, not so may acres. The I way I see it is, there had to be something going on. This 2.29 acres (which is in red on the map) matches what the legal description says and what it says in the Resolution.

Arnold Beach: If, I am saying if, you take out the

Elvis: What really happen is that the brass point is not correct. Arnold how does a Resolution work? Arnold Beach: When passed unanimously, Resolutions become law of the land. Resolutions can only become amended by the person who asked for the resolution, in this case the land board, or the Tribal Council.

Elvis: What about the Church Leases for the reservation?

Arnold Beach: I was the one who motion to table the Church leases for the reservation. Why? Because the tribe wanted to charge all churches 100.00 a year and yet, come to find out they charged the Rick Lupe building under the BIA a \$1.00 and yet they are letting seven tribal members go and hire other non tribal members. The tribe also has WMACO pay \$10.00 every 10 years. May I make a suggestion, I suggest that when you go before the Tribal Council next time, make sure you have how big of the area is approved for these people when it comes to home sites, farmland, and businesses. Thank You.

Phoebe: I agree to go by what the Resolution says. I will make a motion for it.

Raymus: I always wondered where does the ride of way start and end for the town of McNary?

Elvis: Yeah, where does the town of McNary begin and end?

Arnold Beach: In 2007 it was agreed that from the Smoke Shop to the first fence line in McNary is to be set aside for business.

Beverly: I would like to say something, the impression I am getting here is that you think Jack is doing whatever he wants but he isn't. We started this church to help the community. The people of McNary use the church to host certain events let a pet clinic or community events.

<u>Colbert:</u> I have a question for councilman Beach and the Land Board. Where does the community fit in all

of the planning? All of this wouldn't have started if one community member didn't write a letter. Shouldn't the community have a say in what happens in their area as far as what business is involved? The land board meeting in February was cancelled. Cassie filled out paperwork to get a special meeting with council but has been giving not date yet.

Elvis: Where does it say that then? It doesn't say that in here. It seems like the Tribal

Elvis: Where does it say that then? It doesn't say that in here. It seems like the Tribal Attorney is saying one thing to you and then saying another thing.

Joe Harvey: I can add to that. I have been out of a job for over a year now. I was let go because I know a lot of things. I know how things should be run. I was asking questions and they like that. I was doing their job. So they put a stop to everything by getting rid of me. Right now, everything is in a standstill until election season is over. I do agree that something needs to be changed in this resolution.

Elvis: We are the Land Board. We have no control over infrastructure. That is between whoever assigns the land and the person getting the land. I think the Tribe should start looking elsewhere for land. Maybe away from town. Everything around town or close to town is already taken so they need to start looking elsewhere.

Joe Harvey: Everything begins with wording. Things need to change, but I don't know if that will happen. The Constitution needs to be change. The administration needs to be change. We are suppose to have top notch people working for us in the legal department. But look at what was written in the resolution here. They didn't do things right. I was chased out by the legal department, business depart and court department because I am a smart man, going around asking questions that I shouldn't be asking. Legal stepped in and got me out.

Phoebe: Can we get on with the agenda?

Verizon Consultant

Reg Destree: Hello, my name is Reg Destree. I am a consultant with Verizon and today I am here to discuss with you what Verizon has in mind. We are looking at seven cell sites to provide coverage for Verizon customers. The first site we have in mind is at Sunrise. We are proposing to put up a 150 foot pole on the existing maintenance area.

Verizon are considering seven other sites on the reservation to use to construct their cell towers. Sunrise, Cooley Mountain, Show Low, Seven Mile and Cibecue.

Joe Harvey: This is Sunrise's land. Shouldn't you go and ask Sunrise first and then come see us. I would like to see some form that Sunrise is in agreement before we can make a decision on an application this important.

Fred Soto: The Tribe is going to be getting the money from Verizon, not Sunrise. From what I know the land belongs to the Tribe. In the end this is going to happen. Land Office, Land Board, TPPR and whoever should be on board. We are being considerate and following the process, but this deal is happening.

Paul: Will there be more coverage by putting up an antenna at the top of Sunrise mountain.

Fred Soto: With Verizon coming in, there will be more coverage. Right now Cellular One is becoming more hostile. But with Verizon moving in, it is going to be competitive. And that is what we want. We want to get more competition to motivate both companies to get better services for the community. I've been working on this project for awhile now.

Although, most of it has been through emails.

Elvis: Will it be fenced in? Does Sunrise know that it is going to be this chuck of land?

<u>Joe Harvey:</u> Asked if anyone wants to motion. <u>Elvis:</u> We are very hesitant to make a decision. **Fred Soto:** Why is there any hesitation?

Elvis: Because of this resolution on the moratorium.

Fred Soto: That refers to residential assignments and not Business. Business will still be moving forward despite this moratorium.

to be present. Ernistine responds, saying that she has guardianship over her mom and has been taking care of all her paperwork since the beginning. Land Board ask if she has and papers stating she has legal guardianship over Elizabeth Cody. Ernistine and Faye tell the Land Board in the past they never asked for that. At the time Kealoha Cody Duman introduces herself to the Land Board and tells them they will bring in Elizabeth Cody and that she is a lawyer and will talk on behalf of the family. Kealoha tells the Land Board that the land was given to Elizabeth Cody legally and properly. It was passed during a Tribal Council meeting by a resolution. And according to the Land Codes any decision made by the Tribal Council shall be final. Not only that by according to the resolution it clearly states that the Tribal Council and Legal department did a thorough investigation before they made their decision.

Adam Henry asked where does Van Hinton, Roberta Classay and Lousie Narcisco fit into this?

Kealoha responded by saying they have documents that go back to the 1950's that the land belonged to her grandmother. Raymus Albert told the Land Board and the family that from what he can remember old man Endfield had given 1 acre of his farmland to his son in law and his daughter, Pat and Louise Narcisco. That is how Pat and Lousie got a piece of Z-19 Canal. Raymus said that he knows the details of how the land dispute started and he was documenting everything waiting to go to court for the Z-19 farmland but that never happen and then out of nowhere Ernestine Cody brings in a resolution saying the Tribal Council gave the land to them without asking him for information. Raymus also says that when he tried to talk about the land dispute, Ernestine keeps cutting him off. That she has always done this.

Kealoha says her concern is any decision made by the Tribal Council is final. The
