

WHITE MOUNTAIN APACHE TRIBE

A Sovereign Tribal Nation

(Approve Councilman Kasey to Work on Updating Dialysis Building)

WHEREAS, members of the White Mountain Apache Tribal community have for many years struggled with problems that stem from drug and alcohol abuse, as well as diabetes and other ailments that lead to kidney failure; and

WHEREAS, councilman Kasey has taken an interest in working with the Dialysis company located in Whiteriver to seek out opportunities to propose a new building for the Whiteriver Area, and potential expansion into Cibecue; and

WHEREAS, the Tribal Council finds it in the best interest of the WMAT, to direct Councilman Kasey to continue seeking out opportunities to further Tribal interests and to ensure that the members of the Tribe have Dialysis services available to them.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby supports Councilman Kasey's efforts to work on proposing a new building for Whiteriver area in conjunction with the Fresenius organization and to do what is necessary to support the Tribal Community and improve services generally available to them. Councilman Kasey shall work with the Legal Department and any relevant parties to update the Council further on this matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on <u>March 4, 2015</u>, duly adopted by a vote of <u>ELEVEN</u> for, <u>ZERO</u> against, and <u>ZERO</u> abstentions by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it under the enumerated powers listed in Article IV, Section 1 of the WMAT Constitution, so ratified on September 30, 1993, and federally recognized pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984).
