



# WHITE MOUNTAIN APACHE TRIBE

A Sovereign Tribal Nation

## (Appointing Wayne Amos as Acting Chief of Police)

*\*\*Rescinded by Resolution 03-2015-53\*\**

- WHEREAS,** the position of Chief of the White Mountain Apache Police Department has become vacant; and
- WHEREAS,** the Chief of Police is essential in managing the day-to-day operations of the Department and its officers, as well as the establishment of goals, objectives, policies and procedures; and
- WHEREAS,** given his prior experience and background, the Tribal Council deems Wayne Amos as qualified to serve as the Acting Chief of Police until the position is filled through a competitive application process; and
- WHEREAS,** for the reasons stated above, the Tribal Council finds it in the best interest of the Tribe to take the aforementioned administrative actions with the main goal of returning the White Mountain Apache Police Department to a viable Tribal operation.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby appoints Wayne Amos as the Acting Chief of Police until such time as the acting designation is removed or a replacement is selected through a competitive application process.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances or Federal Laws, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on MARCH 11, 2015 duly adopted by a vote of EIGHT for, ZERO against, and TWO abstentions by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it under the enumerated powers listed in Article IV, Section 1 of the WMAT Constitution, so ratified on September 30, 1993, and federally recognized pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984).
