



WHITE MOUNTAIN APACHE TRIBE

A Sovereign Tribal Nation

(Approving First Continuance of Fiscal Year 2015-2016 Budget)

WHEREAS, as of this date, the Tribal Council is undertaking a review of program budgets for Fiscal Year May 1, 2015 through April 30, 2016; and

WHEREAS, the budget review for Fiscal Year 2015-2016 is not yet completed and for that reason the Tribal Council seeks a budget continuation to maintain program budgets at the Fiscal Year 2013-2014 level until such time as the review is completed; and

WHEREAS, the Tribal Council has made strong recommendations that the Tribe should take measures to limit expenditures to essential costs (Salaries, Payroll Taxes, Utilities, and Fuel); and

WHEREAS, the Tribal Council finds that a continuance of the Fiscal Year 2015-2016 budget for a period of three (3) months, beginning May 1, 2015 through July 31, 2015, is in the best interest of the programs, enterprises and the Tribe and that said continuance shall continue in force and effect until such time as the Tribal Council may review and consider the Fiscal Year 2015-2016 budget.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that a continuance of the Fiscal Year 2015-2016 budget is hereby authorized for all Tribal Enterprises and Central Tribe departments for a period of three (3) months, beginning May 1, 2015 through July 31, 2015, at a level not to exceed the Fiscal Year 2013-2014 budget level on a per month pro rata basis.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the continuance authorized herein shall continue until such time as the Tribal Council may review, consider and otherwise act on the Fiscal Year 2015-2016 budget.


BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.


Resolution No. 04-2015-75
