

## WHITE MOUNTAIN APACHE TRIBE

A Sovereign Tribal Nation

(Authorizing the Deputization of Off-Reservation Law Enforcement Officers for the 90<sup>th</sup> Annual Tribal Fair & Rodeo)

WHEREAS, the Tribal Council of the White Mountain Apache Tribe ("Tribe") is entrusted by the Tribe's Constitution to act in all matters that concern the welfare of the Tribe, to manage all economic affairs and enterprises of the Tribe, and to regulate subordinate organizations for economic and other purposes; and

WHEREAS, the White Mountain Apache Tribal Fair and Rodeo is an annual occurrence which takes place over Labor Day weekend; and

WHEREAS, the White Mountain Apache Police Department has requested assistance and support from outside agencies during the fair weekend; and

the Tribal Council of the White Mountain Apache Tribe has determined that it is in the WHEREAS, best interest of the Tribe to allow for the deputization of off-reservation Law Enforcement Officers, to wit: Navajo Nation Police, Bureau of Indian Affairs Law Enforcement, Apache County Sheriff's Office, Arizona Department of Public Safety -GITTEM/Motorcycle Units/Patrol Units, Yavapai Apache Nation Police Department, Salt River Indian Police Department, Gila River Indian Community Police Department, Hualapai Police Department, Tohono O'odham Police Department, Hopi BIA Police Department, Hopi Resource Enforcement Services, Gila County Sheriff's Office, Tonto Apache Tribal Police Department, Show Low Police Department, Pinetop-Lakeside Police Department, San Carlos Apache Police Department, San Carlos Recreation and Wildlife Rangers, San Carlos Adult/Juvenile Rehabilitation, Detention Center & Canine Teams, Jicarilla Apache Police Department, Navajo County Sheriff's Office, Bureau of Indian Affairs, Mescalero Agency, Holbrook Police Department, Snowflake Police Department, Eager Police Department, Springerville Police Department, Colorado River Indian Tribe Law Enforcement Services; and

WHEREAS, the Tribal Council of the White Mountain Apache Tribe consents to deputize the above named departments as White Mountain Apache law enforcement agents to enforce the laws of the White Mountain Apache Tribe for a period not to exceed eight (8) days; and

WHEREAS, the Tribal Council of the White Mountain Apache Tribe requests that the White Mountain Apache Police Department annually coordinate with officers of the above mentioned agencies to accommodate the necessity of law enforcement for this annual event; and

WHEREAS, the officers of the above mentioned agencies agree to coordinate all on-reservation activities with the Chief of the White Mountain Apache Police Department; and

**WHEREAS,** The Tribal Council finds it in the best interest of the Tribe to authorize the Deputization of off-reservation officers annually for this event as considered hereto.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby annually deputizes officers of the Navajo Nation Police, Bureau of Indian Affairs Law Enforcement ,Apache County Sheriff's Office, Arizona Department of Public Safety - GITTEM/Motorcycle Units/Patrol Units, Yavapai Apache Nation Police Department, Salt River Indian Police Department, Gila River Indian Community Police Department, Hualapai Police Department, Tohono O'odham Police Department, Hopi BIA Police Department, Hopi Resource Enforcement Services, Gila County Sheriff's Office, Tonto Apache Tribal Police Department, Show Low Police Department, Pinetop-Lakeside Police Department, San Carlos Apache Police Department, San Carlos Recreation and Wildlife Rangers, San Carlos Adult/Juvenile Rehabilitation, Detention Center & Canine Teams, Jicarilla Apache Police Department, Navajo County Sheriff's Office, Holbrook Police Department, Snowflake Police Department, Eager Police Department, Springerville Police Department, Colorado River Indian Tribe Law Enforcement Services during the first and second weeks of September at the request of the White Mountain Apache Police Department.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes the officers of the above mentioned agencies to coordinate all on-reservation activities with the Chief of the White Mountain Apache Police Department.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on <u>JULY 8, 2015</u> duly adopted by a vote of <u>TEN</u> for, <u>ZERO</u> against, and <u>ZERO</u> abstentions by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it under the enumerated powers listed in Article IV, Section 1 of the WMAT Constitution, so ratified on September 30, 1993, and federally recognized pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984).
