

## WHITE MOUNTAIN APACHE TRIBE

## A Sovereign Tribal Nation

(Approval of Sale of Carbon Credits Offsets)

- WHEREAS, the Tribal Council of the White Mountain Apache Tribe (the "Tribe") is entrusted by the Tribe's Constitution to act in all matters that concern the welfare of the Tribe, to manage all economic affairs and enterprises of the Tribe, and to regulate subordinate organizations for economic and other purposes; and
- WHEREAS, the Tribe has developed a carbon sequestration project named the "White Mountain Apache Tribe Forest Carbon Project, ARB Project ID #CAFR5072 ("Project"), which is subject to the California Air and Resource Board Cap and Trade regulations; and
- WHEREAS, the Tribe has been issued Project related California Carbon Offsets ("CCOs"); and
- WHEREAS, the Tribe wishes to enter into a Transaction Terms Agreement and Transaction Confirmation for California Offset Transactions ("Agreements") with BP Products North America, Inc. ("BP"), such Agreements which are substantially in the form presented to Tribal Council contemporaneously with this Resolution; and
- **WHEREAS**, pursuant to the terms of the Agreements, the Tribe will transfer CCOs to BP and BP will pay the Tribe for such CCOs in accordance with and the manner provided in the terms of the Agreements; and
- WHEREAS, the Tribal Council has determined that entering into and executing the Agreements (including the limited waiver of sovereign immunity provided therein) is in the best interests of the Tribe; and
- WHEREAS, given the urgency of the transactions and agreements, the Tribal Council further finds that the sale of carbon credit offsets needs to be considered and made outside of its regularly scheduled meeting; and
- WHEREAS, the Tribal Council further finds that: (1) this Resolution may be voted upon by signature of a member of the Tribal Council where a signature indicates a vote for this Resolution, (2) the Tribal Council Secretary should attempt to obtain signatures for members of the Tribal Council personally, (3) no signature would mean that the respective Tribal Council member is against this Resolution, (4) the Tribal Council Secretary should wait no longer than a reasonable period of time to obtain a vote by signature or by no signature and so indicate that this Resolution was presented to the respective member of the Tribal Council for a vote.

**BE IT RESOLVED** that the form, terms and provisions of the Agreements, together with all exhibits, attachments, schedules or other appendices appended thereto or referred to therein, and transactions contemplated therein, and all actions necessary for the consummation of the same (including the limited waiver of sovereign immunity, consents to jurisdiction and arbitration provisions contained therein) are authorized and approved in all respects.

**BE IT FURTHER RESOLVED** that the Tribe does hereby approve and authorize the execution, issuance, delivery and performance of the Agreements, together with all exhibits, attachments, schedules or other appendices appended thereto or referred to therein.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that given the urgency of the request described herein, this Resolution may be voted upon as follows: (a) by signature of a member of the Tribal Council, including the Chairman of the Tribal Council and the Vice-Chairman of the Tribal Council, where a signature indicates a vote for this Resolution, (b) the Tribal Council Secretary shall attempt to obtain signatures for members of the Tribal Council personally, (c) no signature shall mean that the respective Tribal Council member is against this Resolution, (d) the Tribal Council Secretary should wait no longer than a reasonable period of time to obtain a vote by signature or by no signature, and so indicate that this Resolution was presented to the respective member of the Tribal Council for a vote.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances existing as of the date hereof, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

**BE IT FINALLY RESOLVED,** that the Chairman or in his absence the Vice-Chairman of the Tribal Council, on behalf of the Tribe, is hereby authorized to execute, deliver and cause the performance of the Agreements, and is delegated the authority to make such changes as the Chairman (or in his absence the Vice-Chairman) deems necessary, and is further delegated the authority to take and cause to be taken any all additional actions necessary to implement the intent of this Resolution and the Agreements.
