



WHITE MOUNTAIN APACHE TRIBE

A Sovereign Tribal Nation

(Authorizing the Police Department to Release Motor Vehicle Accident Data to the Transportation Department)

WHEREAS, the Transportation Department, in order to effectively plan for new transportation facilities and infrastructure and improve existing transportation facilities and infrastructure, requires the collection of data and statistics relating to accidents involving motor vehicles from Police Department; and

WHEREAS, these data and statistics must be shared with departments and agencies within the Tribe and with third parties such as ADOT as part of the effective planning and improvement of new and existing transportation facilities and infrastructure; and

WHEREAS, these data and statistics are also central in the development of proposals of new projects and in requesting funding for projects to build new or improve existing transportation facilities and infrastructure; and

WHEREAS, it is in the best interest of the Tribe for the Council to authorize the Police Department to collect and share data and statistics relating to accidents involving motor vehicles with the Transportation Department on a continuing basis without further need to petition the Tribal Council for reauthorization.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes the Transportation Department to collect data and statistics relating to motor vehicle accidents from the Police Department for the purposes of planning new transportation facilities and infrastructure and improving existing transportation facilities and infrastructure.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes the Transportation Department to share data and statistics relating to motor vehicle accidents with departments and agencies within the Tribe and with third parties for the purposes of planning and improvement of new and existing transportation facilities and infrastructure and in requesting funding for projects to build new or improve existing transportation facilities and infrastructure.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes the Police Department to collect and share data and statistics relating to motor vehicle accidents with Transportation on a continuing basis without further need to petition Tribal Council to petition for reauthorization.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on **MARCH 2, 2016** duly adopted by a vote of **TEN** for, **ZERO** against, and **ZERO** abstentions by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it under the enumerated powers listed in Article IV, Section 1 of the WMAT Constitution, so ratified on September 30, 1993, and federally recognized pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984).
