## **(Approving Certification of General Election Results)**

---

**WHEREAS**, Article VI of the Tribal Constitution of the White Mountain Apache Tribe requires regular elections to be held for Tribal Council; and

**WHEREAS**, the General Election was held by the White Mountain Apache Tribe on Wednesday, April 6, 2016, wherein Tribal Council candidates who were certified to the Tribal Council on February 4, 2016, submitted their names to a vote of the people for Council Offices in Districts I, II, III and IV; and

**WHEREAS**, the Tribal Election Commission has certified to the Tribal Council of the White Mountain Apache Tribe that the General Election is complete and has been carried out in accordance with provisions of the Tribal Constitution and the Election Code of the White Mountain Apache Tribe, and has certified that of the total of 3,637 ballots cast, the following number of votes were received by the individuals listed below whose names were on the ballot for the following offices:




