WHEREAS, the White Mountain Apache Tribe and Johns Hopkins have worked continuously to develop various program and research studies combat the various health disparities among the Apache community; and

WHEREAS, the programs has attracted numerous interests and requests to assist other Native American communities to establish similar programs or learn from the work being done on the White Mountain Apache Reservation; and

WHEREAS, because of the development and implementation of various programs and research studies by the White Mountain Apache Tribe in partnership with Johns Hopkins, the Indian Health Service Head Quarters in Rockville, MD has requested articles to be published in the *Indian Health Service Primary Care Provider Newsletter* for all Indian Health Service Units throughout the United States to learn about;


BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that article submissions are approved from January-December 2016 with consideration there will be minor edits pertaining to each article and that not all study projects will be requested for article submission.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.


BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on APRIL 20, 2016 duly adopted by a vote of ELEVEN for, ZERO against, and ZERO abstentions by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it under the enumerated powers listed in Article IV, Section 1 of the WMAT Constitution, so ratified on September 30, 1993, and federally recognized pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984).
