(Approval for the White Mountain Apache Head Start Program Cost Of Living Adjustment (COLA) 1.8% Funding Application)

WHEREAS, the Tribal Council of the White Mountain Apache Tribe ("Tribe") is entrusted by the Tribe's constitution to act in all matters that concern the welfare of the Tribe, to manage all economic affairs and enterprises of the Tribe, and to regulate subordinate organizations for economic and other purposes;

WHEREAS, the purpose of this agreement is for the White Mountain Apache Head Start Program to apply for the available Fiscal Year 2016 Head Start funding increase. The portion of the funding will provide a Cost-Of-Living Adjustment (COLA) of 1.8% to assist grantees in increasing staff salaries and fringe benefits to pay for higher operating cost.

WHEREAS, Funds remaining after providing the COLA increase in the hourly rate of pay will be used to offset increase operating cost in other areas of the budget. This includes increase cost in rent, facilities maintenance and insurance, contractual arrangements, vehicle fuel, and maintenance, supplies and equipment.

WHEREAS, the WMAHS Program will submit the Supplemental Application which will include the Narrative, Budget and detailed Budget Justification.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the Cost-Of-Living Adjustment Supplemental Application of 1.8% for the White Mountain Apache Head Start Program.


BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on **June 14, 2016** duly adopted by a vote of 6 for, 0 against, and 0 abstentions by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it under the enumerated powers listed in Article IV, Section 1 of the WMAT Constitution, so ratified on September 30, 1993, and federally recognized pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984).
