WHEREAS, Resolution 05-2016-94, appointed members to the Fair and Rodeo Commission; and

WHEREAS, Rhoda Ashley and Shannon James are inactive members and it has been recommended that Dewey Lupe and Farrah Thompson be appointed to replace the respective positions on the Fair and Rodeo Commission; and

WHEREAS, the Tribal Council believes that the appointment of Dewey Lupe and Farrah Thompson, on a voluntary basis, is in the best interest of the Tribe and the annual White Mountain Apache Tribal Fair & Rodeo festivities.




BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby amends the appointment of the Fair and Rodeo Commissioners as follows: Renell Williams - Technical Assistant, Rose M. Kasey - Night Performance, Dewey Lupe - Live Events, Shyanne E. Dewayne - Exhibits, Merial Goklish - Rodeo/ Bull Bash, Marcia Altaha - Parade, Farrah Thompson - Pageants and Cairo Clay - Public Relations/ Marketing.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on **JULY 12, 2016** duly adopted by a vote of **NINE** for and **ZERO** against with **ZERO** abstaining by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it under the enumerated powers listed in Article IV, Section 1 of the WMAT Constitution, so ratified on September 30, 1993, and federally recognized pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984).
