



WHITE MOUNTAIN APACHE TRIBE

A Sovereign Tribal Nation

(Authorizing the Diabetes Wellness Program and the Division of Health Programs to Develop Treatment Prevention Services for Diabetic Clients and Their Families)

WHEREAS, the Tribal Council recognizes that diabetes is a major health problem on the Fort Apache Indian Reservation; and

WHEREAS, the Diabetes Wellness Program/Division of Health Programs is the primary tribal provider of diabetes prevention and supportive treatment services to the members of the White Mountain Apache Tribe; and

WHEREAS, the Executive Director of the Division of Health Programs, the Health Board and the Diabetes Wellness Program wish to expand the scope and amount of emotionally supportive treatment services offered to diabetic and pre-diabetic Tribal Members and their families; and

WHEREAS, it is beneficial for Tribal health care programs to locate and obtain sustainable third-party funding to maintain its programs; and

WHEREAS, the Tribal concurs with the representative of the Division of Health Programs and finds it in the best interest of the Tribe to allow third-party funding.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes the Diabetes Wellness Program/Division of Health Programs to design and implement a diabetic/mental health treatment program to decrease the threat of diabetes on the reservation.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes the Diabetes Wellness Program/Division of Health Programs to seek out methods whereby it may obtain third-party payer systems to assist in financial support of its programs.


BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.


