



WHITE MOUNTAIN APACHE TRIBE

A Sovereign Tribal Nation

(Approval to Amend the Schedule of Court Fees)

WHEREAS, pursuant to Section 2.18(A), the Chief Judge of the Tribal Court, in consultation with the Associate Judges, shall promulgate Rules of the Court to govern the proceedings and operation of the Trial Court; and

WHEREAS, the Chief Judge, Associate Judge and Juvenile Judge have concurred that the existing Schedule of Court Fees be revised; and

WHEREAS, the proposed fees are necessary to recover a minimal rate of administrative services provided to those who have a dire consequence to appear before the Court; and

WHEREAS, the Tribal Council finds it in the best interest of the White Mountain Apache Tribe approve the revised Schedule of Court Fees.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorized the revised Schedule of Court Fees, effective immediately.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on APRIL 5, 2017 duly adopted by a vote of ELEVEN for, ZERO against, and ZERO abstentions by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it under the enumerated powers listed in Article IV, Section 1 of the WMAT Constitution, so ratified on September 30, 1993, and federally recognized pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984).
