



# WHITE MOUNTAIN APACHE TRIBE

## A Sovereign Tribal Nation

### (Native Vision Walking Trail )

---

**WHEREAS,** the White Mountain Apache Tribe and Johns Hopkins University have collaborated to conducted research projects for 37 years which aim to raise the level of health of all residents of the Reservation; and

**WHEREAS,** the Tribal Council supports the efforts and assistance that Johns Hopkins University has given to the White Mountain Apache Tribe to identify health problems which exist in the community and to develop appropriate interventions which seek to decrease or alleviate these problems; and

**WHEREAS,** the Native Vision year-round program was approved by Tribal Council (resolution #10-2009-338) for Johns Hopkins to conduct a Native Vision After School Fitness and Life Skills Program ("Native Vision") for youth ages 9 to 12 year olds in Cibecue and Whiteriver; and

**WHEREAS,** Mike and Ellen Kullman have given significant financial support to Johns Hopkins Center for American Indian Health specifically for Native Vision program in order to sustain the program; and

**WHEREAS,** in recognition of the Kullman family, Johns Hopkins Center for American Indian Health would like to build or renovate a walking trail somewhere in the Whiteriver vicinity to encourage and promote physical activity and exercise, one of Native Vision's goals and place a plaque at the start of the trail thanking the Kullman's for their generosity, given that the White Mountain Apache Tribe was the initial site for the Native Vision year-round program and has a long outstanding history with our Center; and

**WHEREAS,** discussion with Division of Heath programs and youth council have taken place to identify the best location, which is (need to insert).

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby approves Johns Hopkins to build or renovate a walking trail somewhere in the Whiteriver vicinity to encourage and promote physical activity and exercise, one of Native Vision's goals and place a plaque at the start of the trail thanking the Kullman's for their generosity.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

**Resolution No. 05-2017-97**

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on **MAY 3, 2017** duly adopted by a vote of **NINE** for, **ZERO** against, and **ONE** abstentions by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it under the enumerated powers listed in Article IV, Section 1 of the WMAT Constitution, so ratified on September 30, 1993, and federally recognized pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984).
