



# WHITE MOUNTAIN APACHE TRIBE

A Sovereign Tribal Nation

## ( Educational Assistance for Barney Gregg )

**WHEREAS,** the Tribal Council is aware that Tribal member, Barney Gregg, is pursuing his forestry degree at Northern Arizona University per Resolution number 08-2016-184; and

**WHEREAS,** Mr. Gregg continues to express his interest and long-term commitment in pursuing his forestry degree in order to assist the Tribal Forestry and the Tribe in its carbon credit investment program; and

**WHEREAS,** the Tribal Council finds it in the best interest of the Tribe to continue to provide educational financial assistance in the amount of \$6,500 for the Spring of 2018 semester and \$6,500 for the Fall of 2018 semester.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby approves Barney Gregg to receive education financial assistance, in the amount of \$6,500 for the Spring semester of 2018 to be paid no later than March 2018, and \$6,500 for the Fall semester of 2018 to be paid no later than September 2018.


**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes Tribal Forestry to utilize funds generated from carbon credit sales to cover such expenses for Mr. Gregg, so long as previous semester cumulative grade point average is 2.5 or greater based on an official transcript.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on JANUARY 17, 2018 duly adopted by a vote of NINE for, ZERO against, and ZERO abstentions by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it under the enumerated powers listed in Article IV, Section 1 of the WMAT Constitution, so ratified on September 30, 1993, and federally recognized pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984).
