

WHITE MOUNTAIN APACHE TRIBE

A Sovereign Tribal Nation

(Approving Burial Assistance for Former Councilman Floyd Walker's Family)

WHEREAS, former Councilman Floyd Walker has a death in his family and the Tribal Council extends its sincere condolences to the Walker Family; and

WHEREAS, the minor child is not eligible for enrollment with the White Mountain Apache Tribe and

WHEREAS, former Councilman Floyd Walker would like to request burial benefits of \$1,500 afforded to former council members; and

WHEREAS, the Tribal Council finds it in the best interest of the tribe to grant former Councilman Floyd Walker's request.

BE IT RESOLVED that the Tribal Council of the White Mountain Apache Tribe hereby approves former Councilman Floyd Walker's request for burial benefits of \$1,500 afforded to former Council members of the WMAT.

BE IT FURTHER RESOLVED a check be made payable to Mrs. Belinda Walker in the amount of \$1,500 for the purpose of covering funeral expenses for former Councilman Walker's granddaughter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that given the urgency of the request described herein, the Resolution may be considered outside of the Tribal Council's regularly scheduled meeting and voted upon as follows: (a) by signature of a member of the Tribal Council, including the Chairwoman of the Tribal Council and the Vice-Chairman of the Tribal Council, where a signature indicates a vote for this Resolution, (b) the Tribal Council Secretary shall attempt to obtain signatures for members of the Tribal Council personally, (c) no signature shall mean that the respective Tribal Council member is against this Resolution, (d) the Tribal Council Secretary should wait no longer than a reasonable period of time to obtain a vote by signature or by no signature, and so indicate that this Resolution was presented to the respective member of the Tribal Council for a vote.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairwoman, or in her absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on <u>October 10, 2018</u> duly adopted by a vote of for, <u>ZERO</u> against, and <u>ZERO</u> abstentions by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it under the enumerated powers listed in Article IV, Section 1 of the WMAT Constitution, so ratified on September 30, 1993, and federally recognized pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984).
