



WHITE MOUNTAIN APACHE TRIBE

A Sovereign Tribal Nation

(Authorizing Burial of Non-Tribal Member Rolondo Justin Henry Jr.)

WHEREAS, the Tribal Council has been advised that the infant son of Rolondo Justin Henry Sr. and Brianna Ann Vanderhyde, Rolondo Justin Henry Jr., passed away, and that funeral arrangements are pending; and

WHEREAS, the decedent's family requests that the Tribal Council authorize the deceased, Rolondo Justin Henry Jr, to be buried at Running Water Cemetery in Cibecue; and

WHEREAS, although Rolondo Justin Henry Jr. was not a member of the White Mountain Apache Tribe, the Tribal Council finds that the request made herein should be granted as Rolondo Justin Henry Sr. was raised in Cibecue by Darlene Beach and has ties to the community; and

WHEREAS, the Tribal Council finds that the assistance provided herein is consistent with the culture and tradition of White Mountain Apache and in sympathy to the family; and


BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby grants permission to the Rolondo Justin Henry Jr. family to bury the remains of the decedent, Rolondo Justin Henry Sr., at the Running Water Cemetery in Cibecue.


BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairwoman, or in her absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on JULY 3, 2019 duly adopted by a vote of ELEVEN for, ZERO against, and ZERO abstentions by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it under the enumerated powers listed in Article IV, Section 1 of the WMAT Constitution, so ratified on September 30, 1993, and federally recognized pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984).
