(Approving Land Board's Recommendation Regarding Filmore Wool Homesite Land Assignment)

- WHEREAS,** Filmore Wool, a member of the White Mountain Apache Tribe and a Military Veteran, was approved for a homesite assignment by the Tribal Land Board on July 24, 2019; and
- WHEREAS,** The Housing Authority has advised the Tribal Council that they unexpectedly received more funding for the Veteran Project and are able to rehabilitate four additional homes and construct a new home for a deserving Veteran of the Tribe; and
- WHEREAS,** Mr. Filmore Wool has been selected as the tribal member Veteran who will receive the new three-bedroom home, to be constructed on his homesite located in Whiteriver; and
- WHEREAS,** this project will involve the assistance of Wells Fargo Volunteers, the Veteran recipients and their families, the White Mountain Apache Housing Authority, and any member of the public who wishes to help put in volunteer hours towards this project; and
- WHEREAS,** Wells Fargo Volunteers are planning to be on site on September 14, 2019 to perform volunteer work on the new construction unit and the four rehabilitation units; and
- WHEREAS,** The Housing Authority is requesting that the Tribal Council expedite the process of Tribal Council approval of Land Board assignments in the case of Filmore Wool as construction cannot begin on his home until the completed land assignment document is received.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the homesite assignment of Filmore Wool, located in the Whiteriver Community, which was approved at the Land Board level on July 24, 2019.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairwoman, or in her absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.


Resolution No. 07-2019-160
