



WHITE MOUNTAIN APACHE TRIBE
A Sovereign Tribal Nation

**(Appointing Tribal Vice Chairman Jerome Kasey III
to the Indian Health Services Direct Services Tribal
Advisory Committee as an Alternate from the Phoenix Area)**

WHEREAS, The Constitution of the White Mountain Apache Tribe (“Tribe”) of the Fort Apache Indian Reservation (“Constitution”) provides, at Article IV, Section 1(a) that the Tribal Council (“Council”) shall exercise the power “[t]o represent the tribe and act in all matters that concern the welfare of the Tribe, and to make decision not inconsistent with or contrary to this constitution”; and

WHEREAS, The Tribal Council has the responsibility of appointing individuals to serve on the Direct Services Advisory Committee on behalf of the White Mountain Apache Tribe and has determined that such representation should come from within the governing body; and

WHEREAS, Tribal Vice Chairman Jerome Kasey III has been nominated to serve on the Direct Services Tribal Advisory Committee; and

WHEREAS, The Tribal Council finds it in the best interest of the Tribe to appoint Vice Chairman Kasey to serve on the Direct Services Tribal Advisory Committee.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby appoints Tribal Vice Chairman Jerome Kasey to serve on the Indian Health Services Direct Services Advisory Committee as an Alternate representing the Phoenix Area.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairwoman, or in her absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on NOVEMBER 10, 2021 duly adopted by a vote of TEN for, ZERO against, and ZERO abstentions by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it under the

Resolution No. 11-2021-228

enumerated powers listed in Article IV, Section 1 of the WMAT Constitution, so ratified on September 30, 1993, and federally recognized pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984).
