(Approving 2022 Primary Election Results and Certification of Candidates for the General Election)

WHEREAS, Article VI of the Tribal Constitution of the White Mountain Apache Tribe (“Constitution”) requires regular elections to be held for Tribal Council; and

WHEREAS, Pursuant to Article VI, Section 8 of the Constitution, the Tribal Council (“Council”) adopted an Election Ordinance that mandates that a Primary Election be held on the first Wednesday of February during an election year, established by Article VI, Section 1 of the Constitution; and

WHEREAS, The White Mountain Apache Tribe held its 2022 Primary Election on Wednesday, February 2, 2022, wherein Tribal Council candidates submitted their names to a vote of the people for the Office of the Chairman; and

WHEREAS, Primary Election contests were not held for the Offices of District I Council Representative, District II Council Representative, District III Council Representative, District IV Representative or the Office of Vice Chairman because there were not enough candidates running for office to require a primary contest; and

WHEREAS, The Tribal Election Commission, this day, has certified to the Tribal Council that the Primary Election is complete and has been carried out in accordance with the provisions of the Constitution and the Election Code of the White Mountain Apache Tribe, and has certified that of the total of 2,998 ballots cast, the following number of votes were received by the individuals listed below whose names were on the ballot for the following office:
