



WHITE MOUNTAIN APACHE TRIBE

A Sovereign Tribal Nation

(Enacting Ordinance No. 310, Amending the Criminal Code of the White Mountain Apache Tribe)

WHEREAS, The Tribal Council of the White Mountain Apache Tribe (“Tribe”) is entrusted by the Tribe’s Constitution, Article IV, Section 1(q) to act in all matters that concern the welfare of the Tribe, including but not limited to, the amendment of codes through the adoption of ordinances; and

WHEREAS, Ordinance No. 310 proposed changes to the Criminal Code; and

WHEREAS, On April 14, 2022, the Tribal Council authorized the posting of Ordinance No. 310 through Resolution No. 04-2022-76, pursuant to Article XV of the Constitution of the White Mountain Apache Tribe and it was posted on April 25, 2022. Since that time, the Office of the Tribal Council Secretary has received no comments regarding the proposed changes; and

WHEREAS, The Council has reviewed Ordinance No. 310 carefully, and considered the recommendations and implications thereof in great detail, and finds the adoption of the amendments to the Criminal Code as set forth in Ordinance No. 310 to be in the best interests of the White Mountain Apache Tribe.

BE IT ENACTED by the Tribal Council of the White Mountain Apache Tribe that it hereby adopts Ordinance No. 310, attached hereto and incorporated by reference, which amends the Criminal Code.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.
