



# WHITE MOUNTAIN APACHE TRIBE

## A Sovereign Tribal Nation

### (Appointing Curtis Suttle, Sr. to the Tribe's Housing Board of Commissioners)

---

**WHEREAS,** The Constitution of the White Mountain Apache Tribe ("Tribe") of the Fort Apache Indian Reservation provides, at Article IV, Section 1(s) that the Tribal Council ("Council") shall exercise the power, "To regulate its own procedures, to appoint subordinate committees, commissions, boards, advisory or otherwise..."; and

**WHEREAS,** The White Mountain Apache Housing Authority ("WMAHA") is the Tribe's Tribally Designated Housing Entity; and

**WHEREAS,** The Tribe's Housing Code provides, at Section 11.11(C), that the Housing Board of Commissioners ("Board") "shall consist of not less than five nor more than seven persons, all of whom shall be appointed by the Tribal Council"; and

**WHEREAS,** The Housing Code, further, provides that terms shall consist of four years, or until a successor is duly elected and qualified; and

**WHEREAS,** Council finds, at this time, that appointing Curtis Suttle, Sr., is in the best interests of the Tribe and its members.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that Curtis Suttle, Sr., is hereby appointed to serve on the Tribe's Housing Board of Commissioners for four-year terms or until a successor is duly elected and qualified.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances, or any material facts concerning the issues presented are later found to be false, this Resolution shall be deemed null and void and have no legal effect.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

**Resolution No. 07-2022-191**

The foregoing resolution was on **JULY 6, 2022** duly adopted by a vote of **SIX** for, **ZERO** against, and **TWO** abstentions by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it under the enumerated powers listed in Article IV, Section 1 of the WMAT Constitution, so ratified on November 10, 2021, and federally recognized pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984).
